The first words that spring to mind to describe 2023 are emergency and adaptation.

The year began splendidly with an event at the European Parliament to present women's funds, and ended with a meeting of Mediterranean ecofeminists that we had been dreaming of for years. It featured dozens of meetings and training courses with hundreds of associations from around the Mediterranean, to which over one million euros was granted. Yet 2023 was marked above all by a series of catastrophes that shattered the routines and lives of many of the associations we support - and everyone around them.

First, at the beginning of the year, came the earthquake in Turkey, then, from September onwards, in an accelerating chain of devastating events, the earthquake in Morocco, the Mediterranean cyclone in Libya and, after the Hamas attack on Israel, Israel's retaliation with bombardments leading to the destruction of Gaza.

This acceleration meant that our team had to immediately adjust our pace of work to react swiftly, show our solidarity, gather news and respond to all sorts of requests: urgent requests for aid from the associations working on the ground and urgent requests for contributions from our donors. All this on top of our ongoing work with other associations in other countries.

Moreover, the various challenges encountered throughout the year within our own organization have all called for a great deal of adaptation.

First, because we took more time to finalize our Strategic Plan for the next five years.

We held multiple meetings, between members of the team, between the team and the Board, and with outsiders who have generously contributed to our thinking, to review our strategic direction. In our reflections, we took into account the exponential expansion of the organization (including a budget increase of around 20%), the transition to new management planned for the near future, and the shifting political and philanthropic context in the region. While this required a great deal of effort and flexibility from the entire team, it enabled each member to fully embrace the overall vision and mission of the Mediterranean Women's Fund.

And second, because once again this year, the team experienced several key changes, necessitating rapid adjustments and restructuring. Each of these changes, which included departures (1), arrivals (2), maternity leaves (1), and parental leaves (1), compelled us to adapt our operations to the capacity of a team with new members and some instability in critical positions, such as accounting.

In addition, a lengthy recruitment process concluded in the fall with the appointment of Amina Izarouken to the position of deputy codirector in 2024.

In the end, the need to adapt to all of these unforeseen circumstances and emergencies, however challenging they may have been, enabled us to appreciate the cohesion and maturity of the team. And to end the year with a sense of pride!

I. Strengthening the Women's Movement

A. Support to associations

Women's associations across the Mediterranean are facing many challenges. In addition to the difficulties resulting from cuts in, or even the withdrawal of, funding for gender equality and the extra workload this placed on their shrinking teams, they also must contend, depending on their context, with government repression and/or the aggression of fundamentalist and masculinist movements.

In 2023, the ongoing economic and political crises in many countries on the southern shores were compounded by natural disasters in Turkey, Morocco and Libya, and war in Israel/Palestine.

1. Financial support

• Grant amounts

In 2023, MedWF funded:

160 initiatives, with grants totaling €1,163,180 including €384,500 for emergencies

In addition, MedWF acted as an intermediary for three grants worth €36,882.

A total of €1,200,062 allocated in 2023.

Amounts ranged from \notin 500, for one-off emergency support, to \notin 60,000 provided after the earthquake to our Moroccan partner, the head of a network, for redistribution to the very small associations with which they work.

The increase in grant amounts continued in 2023: we awarded 42 grants above the average, which is now $\notin 7,101$, compared with $\notin 6,934$ in 2022, with the median grant amount still $\notin 5,000$.


In 2023, 25% of the grants were emergency grants. They went to: associations struggling to cover their urgent operating costs (risk of closure of the association (4)); activists to participate in major feminist events that had not been budgeted for (3); and this year, above all, associations in areas hit by natural disasters (1 for the flooding in Libya, 12 for the earthquake in Morocco and 5 for the earthquake in Turkey/Syria) or human disasters such as the shelling in Gaza (13). In all, 41 grants were awarded, for a total of €384,500.

These disasters have forced us to collectively formalize our emergency procedures to respond more effectively.

Breakdown of the grants in the region


This year, we received 200 applications from 18 countries around the Mediterranean. We accepted 80%; the 20% rejected either did not meet our criteria or were not considered a priority (for example, those with a substantial annual budget or general interest associations with one feminist project among their various activities).

We endeavor to balance the distribution of grants as much as possible so that associations around the Mediterranean can receive support. The number of requests varies from one country to another; the distribution of grants is proportional to the demand.

France's particularly large share is due to our desire to strengthen the feminist and anti-racist initiatives of associations in lower-income neighborhoods of Ile-de-France (Sevran, La Courneuve, Saint-Denis, Gennevilliers) and to specific support from our donors earmarked for this purpose.

PERCENTAGE OF NUMBER OF GRANTS ALLOCATED BY COUNTRY




Use of grants by the associations

More and more associations are turning to us directly for support with their operating costs; this year, this concerned 46% of grants.

We are committed to offering them this possibility, which allows associations to consolidate and groups to climb out of precarious situations, so that they can continue to carry out their activities.

We also support individual feminist activists, either to enable them to participate in important events for the defense of women's rights, such as the UN Commission on the Status of Women in New York, or to provide encouragement.


Starting in 2021, we introduced "awards to mobilizers", created to thank and encourage feminist activists who work tirelessly to mobilize women to achieve equality and social change. We continued the program in 2023, awarding four extremely courageous activists who are tackling violence against women, particularly under-age marriage in rural areas of the Moroccan Middle Atlas region. The awards come with no strings attached, and are intended to help these activists not only to continue their work, but above all to look after themselves.



Most of the initiatives we support aim to reach all women, regardless of age, economic or social status, disability, or sexual orientation.

We generally support associations that defend women who are victims of violence, marginalized women (living in precarious conditions, in remote areas, isolated from institutional systems) and migrant and refugee women.


We also do our utmost to support associations that cater specifically to lesbian, bi and transgender women, often overlooked by donors. We continue to receive very few requests from associations of women with disabilities, which are themselves few in number depending on the country.¹




The associations' areas of activity are most commonly combating violence against women, fighting for gender equality, economic empowerment, and peace-building.

¹ It should be noted that the distinction made in this report does not reflect the exact reality: most associations have an intersectional approach and support women who may fall into several categories at once.


TOPICS FINANCED IN PERCENTAGE



The associations receiving the most support are those offering services such as shelters for women victims of violence. Associations also make extensive use of awareness-raising and advocacy to advance women's rights in their countries.



To protect women, raise awareness, advocate and inform the public, associations rely on a variety of approaches: they open safe spaces, provide training, and use cultural and artistic forms of expression and awareness-raising campaigns.

2. <u>Specific support for networks</u>

From the very outset, the Mediterranean Women's Fund has made it one of its priorities to support networks formed by women's associations or individuals committed to women's rights. We believe that these spaces of joint governance, which bring together multiple energies, are crucial to building a strong women's rights movement. During our year-long reflection on our strategy for the next five years, we decided to strengthen this support by giving networks larger grants to enable them to consolidate their coordination offices.

MedFemiNiswiya, the Mediterranean network of feminist journalists

The MedFemiNiswiya network was formed in 2018 by journalists based in Algeria, Croatia, Egypt, Spain, France, Italy, Lebanon, Libya, Malta, Morocco, Montenegro, Palestine, Tunisia, and Turkey, with the help of the MedWF. Working from a feminist point of view, it produces high-quality written, audio and video reports, articles and stories on a wide range of current events. Over the years, the MedWF has supported its development and consolidation, including it among its programs.

This year, MedFemiNiswiya took off, receiving and managing its first grants from other donors. As with other networks, the MedWF continues to provide financial and organizational support. This support has enabled MedFemiNiswiya to cover its operating costs, mainly the fees paid to the team responsible for producing and publishing the online magazine MedFemiNiswiya, interpreting at editorial meetings, translating articles and other operating costs. In May, the MedWF invited MedFemiNiswiya's project officer to take part in the meeting of the "On the Right Track" project, which brings together European and Latin American women's funds and aims to support organizations opposing extreme right-wing political movements.

During the year, the MedFemiNiswiya team also experienced several changes. During this transition phase, it received support from the MedWF, at a team meeting held in France in October, to create a relational charter based on the one already in place within the MedWF.

The network of associations from lower-income neighborhoods in Ile-de-France

This network was established following videoconferences organized by the MedWF and the association Citoyenneté Possible in 2020. Starting in 2022, the 14 women's associations from lower-income neighborhoods that took part in the meetings expressed the need to work together and affirmed their desire to continue consolidating the network. They were joined in 2023 by two new members whom we met at an event organized at the Economic, Social and Environmental Council (CESE) to which we had been invited by Souâd Belhaddad, President of Citoyenneté Possible.

Over the course of the year, four online meetings brought together members of the network to discuss racism following the murder of young Nael by police officers, and the difficulties encountered by the associations in the network faced with the increasing poverty of people living in their neighborhoods, particularly women. Several events, organized by the MedWF and by one of the network's member associations, enabled the network members who attended to see each other in person for the first time, and to make connections based on their areas of work.

2023 also was important for the internal structuring of the network's coordination team, composed of members of Citoyenneté Possible and the MedWF. We worked together to define our working and organizational methods for more effective coordination of the network.

The Front for Equality and Women's Rights in Tunisia

The Front for Equality and Women's Rights (FEDF) is a nationwide Tunisian network of civil society organizations and committed activists working in Tunisia. Officially established at a strategic meeting organized by the MedWF in Hamamet, with some 20 Tunisian associations taking part, this network seeks to strengthen links between associations fighting for equality and women's rights in Tunisia at a time when these are under violent attack.

This network aims to:

- pool their efforts and know-how to promote equality and defend women's rights against all threats and discrimination;
- develop a feminist culture within associations, civil society and society as a whole, and among the general public.

The MedWF's support, both financial and organizational, enabled the FEDF to get off the ground, organize a press conference on April 27 in Tunis to publicly announce its creation, and organize for its members the *Académie du Genre* (Gender Academy) in September, a three-day meeting and training session on women's rights and the history of the feminist movement in Tunisia.

Women's Network of Croatia

While we are sometimes involved in the creation of certain networks, we also support existing ones, such as the Women's Network of Croatia. Once again, this year, our support has taken many forms:

- funding its annual operating costs;
- organization of a strategic reflection meeting, the first since COVID;
- grants for participation in the Commission on the Status of Women (CSW) in New York;
- grants to network member associations;
- invitations to take part in advocacy events with donor-partners, as was the case this year with Fondation CHANEL online Pop-Up event.

The Brave Sisters network for the freedom of Balkan women to have abortions

The MedWF actively supports the Brave Sisters network, which helps women in Croatia, Bosnia and Herzegovina and Serbia who wish to have an abortion.

Brave Sisters is countering a conservative offensive, which is becoming increasingly strong in Croatia, to prevent abortions even though they are legally permitted. It is doing so through its unique website in Serbo-Croatian, which provides information on the steps to be taken by women wishing to terminate their pregnancy, and its growing network of volunteers ready to support them in their efforts.

3. <u>Support beyond grants</u>

When the grant selection committee is interested in a project but the MedWF cannot finance it, or can only do so in part, we try to provide the association the contact information of other donors likely to finance them. The MedWF also sometimes introduces associations to donors. This often involves local companies, but also private foundations and women's funds. Donors are increasingly recognizing the MedWF's expertise, and are now contacting the Fund to identify associations to finance.

This year, we presented some 20 associations to our partner donors, and were also asked several times by our women's fund colleagues to provide an opinion on a local association. We recommended 18, all of which were supported.

Last but not least, the MedWF provides several forms of support to newly-created associations with little experience or which are struggling:

- by helping them to set up their structure and activities, and to articulate their plans for other donors;

- by reinforcing a relationship of transparency and fluid communication, and by adjusting our practices to better understand their expectations of us and to be as close as possible to their needs in the field, notably through on-site visits and videoconferences;
- associations that we support are increasingly asking us to help them think about how they are organized and unblock situations that are hampering their work.

This year, we held several working sessions, either in our Paris offices, online, or locally, with associations or association leaders from France, Algeria, Tunisia, and Morocco, for individual or group coaching on a range of issues, such as managing relationships within the association, preventing burnout, fundraising strategies and financial resilience, networking, and so on.

4. <u>On-site visits</u>

Now that travel and face-to-face meetings are once again possible, the MedWF has resumed its frequent onsite visits to women's associations. These are opportunities for team members to gain a better understanding of the work of the associations they support and the conditions under which this work is carried out, and to strengthen links that often have been formed exclusively online.

Lebanon

In May, we visited our Lebanese and Syrian partners in the Bekaa region and in Beirut. We visited seven of our grantee-partners, some of which have been operating for several years, located in rural and urban areas. We also had the opportunity to exchange ideas and discuss strategies for supporting feminist associations in the region with our friends from the Doria Feminist Fund, and to meet new associations that could become new partners.

Algeria

Several on-site visits took place during 2023, in conjunction with sessions of the Feminist School and other meetings of the women's movement. Two members of the team also carried out a field mission in June, visiting five associations. On each occasion, the MedWF team takes the time to visit the associations on their premises and assess the difficulties they face and their needs.

Tunisia

Two field visits were made to Tunisia, in March and November. The first, which took place exclusively in Tunis, enabled us to meet our three partners supported by the Feminists in Action project: Beity, ATFD and Aswat Nissa. The second was an opportunity to meet the Tigar association and the Ladies First association, located in rural Sidi Bouzid, in addition to Tunis. These visits enabled the team members to familiarize themselves with the Tunisian context, understand the issues at stake, strengthen ties with activists and gain a better understanding of the actions of each of our local partners.

Morocco

Following the training course, we organized in Aït Ourir, we went to meet several associations in the region who welcomed us to their premises; in Aït Ourir, these were the Tafoukte association and the Ytto Haouz association, with which we have an ongoing partnership. They helped us to meet with fledgling associations in the villages around the commune of Tidili Mesfioua, such as the Tyaouine Association for the Development and Empowerment of the Women of Tadouartes and the Afous *Mains dans la Mains* association for rural women, which they would like to support with our help.

France

Several visits took place, often when associations were organizing events such as the preview opening of the Violette and Coop bookshop, the March 8 event organized by Femmes Entraide et Autonomie and a lunch on the premises of the Association des Femmes de Franc-Moisin.

We also took part in the national feminist meetings held from July 12 to 16, 2023 in Mont de Marsan, the aim of which is to create a space for grassroots activists to meet, debate and organize. This enabled us to meet around fifty feminist associations and groups.

Egypt

An initial mission enabled us to visit some associations such as RAWSA Egypt and ACT. These meetings were held to consolidate partnerships and monitor projects, needs, obstacles, and the general state of the movement. The fact that the mission took place during the last week of Ramadan, in April, limited the number of associations the MedWF could meet. It was also an opportunity to discuss the idea of a second MedWF adviser.

Croatia

After the strategic reflection meeting in Zagreb in February, part of the MedWF's team stayed on to make field visits to some of the feminist associations that make up the Women's Network of Croatia, such as Domine in the city of Split, and Earth for Us and Seka House on the island of Brač. These visits were highly instructive and provided a better understanding of the context in which these women work and implement their projects.

B. Organization of meetings, forums for exchange and strategic reflection

Prompted by the observation that associations working for women's rights are swamped with work and rarely have the opportunity to meet each other outside crisis situations, we have organized, over the past few years, strategic reflection meetings bringing together associations from the same country. Since 2011, we have organized these types of meeting in Egypt, Algeria, Tunisia, Croatia, France, and Tunisia (the latter for representatives of Libyan associations). For MedFemiNiswiya, we also have organized meetings in Lebanon, Italy, Morocco, and Tunisia. The use of video-conferencing tools, which has become widespread since the COVID-19 crisis, has enabled us to increase the number of these meetings, particularly in the North Africa and Middle East sub-regions.

Participants discuss the major issues facing them, in relation to their association, daily work, and the situation of women in their area, and reach an agreement on the priority issues to be addressed. Together, they assess what they believe to be their strengths, weaknesses, and the allies on whom they can rely. This inventory enables them to refine collective strategies on which they can agree at the end of the meeting.

On each occasion, our role is to organize the logistics of the meeting and to facilitate discussion by creating a friendly atmosphere, ensuring a fair distribution of speaking time and providing a faithful record of what was said. The absence of any obligation to achieve results at these meetings, and the presence of a third party such as the MedWF, make it possible to change communication habits associated with emergencies and existing local power relations, habits which often hinder the implementation of joint long-term strategies.

We organized online meetings throughout the year, regularly with associations from lower-income neighborhoods in Ile-de-France to consolidate the existing network, and this year, also for the nascent Tunisian network, the Front for Equality and Women's Rights.

We also organized occasional online meetings on specific topics.

Two meetings on cybersecurity were organized in May and September, for Egyptian, Palestinian and Lebanese associations. Thanks to the contribution of experts in the field, including our partner Frontline Defenders, participants were able to acquire the skills and information needed to better protect their data and that of their associations on their phones, computers, tablets and the internet.

In October, we organized an online meeting that brought together around ten women's associations in Libya to take stock of the situation of women following the floods in the Derna region and the assistance that could be provided to women in the affected regions, including the implementation of first aid measures. And lastly, after hoping to be able to do this for years but without managing to set it up, we were finally able to bring together Mediterranean feminists committed to climate justice in Paris for two days.

1. Strategic Reflection Meeting in Tunisia

Following a meeting in November 2022, at which the creation of a Tunisian network figured among the conclusions, the team traveled to Hammamet on March 4 and 5 to organize a strategic reflection meeting. This meeting brought together 22 women representing 20 feminist associations from across the country (rural and urban areas). A dedicated working group, made up of several representatives, had spent the period from November to February drafting the network's founding documents (*see above the presentation of the Front for Equality and Women's Rights*).

This second meeting in March focused on studying these documents and working on them collectively and in small groups to make changes to ensure that all of the associations represented agreed on the values, objectives and operating rules of the future network. After two days of discussions, a charter of values, a relational charter and a set of internal operating rules were approved by all those present at the meeting. The texts were signed by the 22 participants, and the Front for Equality and Women's Rights was born. The newly-formed network was made official at a press conference on April 27.

2. Strategic Reflection Meeting in Lebanon

We organized a meeting in Lebanon in early May, bringing together in Beirut 19 representatives of 19 feminist associations from across the country.

For several years, Lebanon has been mired in an unprecedented economic, political and social crisis, with power cuts, unstable internet connections, a devalued Lebanese pound and sharp price hikes. The MedWF felt it was necessary to create a forum in which Lebanese associations could come together to define their strategies and activities.

Our objectives for this meeting were as follows:

 strengthen our local bases and networks, and our links with representatives of Lebanese associations;

- analyze with them the situation of the women's movement in the country and in the region;
- identify priorities to determine our strategy for strengthening women's rights associations.

After two days of work and collective reflection, the Lebanese associations present identified three main priorities:

- ensuring the continuity of services and self-care despite the situation;
- empowerment through training and education, transmission, and networking;
- lobbying for changes in the law.

3. Strategic Reflection Meeting in Croatia

The MedWF organized a strategic reflection meeting attended by 29 participants, representing 20 organizations from 14 Croatian cities. The meeting took place in Zagreb. This is the 7th strategic reflection meeting of the women's movement in Croatia.

Among the main issues raised were the burnout of feminist activists, the difficulties and shortage of flexible funding, and the exodus of Croatian youth in general and young women in particular. In short, a rolling back of rights and growing oppression. However, since 2018, there have been victories as some organizations have managed to secure regular funding rather than waiting for and constantly responding to infrequent calls for tenders. In addition, the Croatian network is developing and striving to consolidate coordination efforts and advocacy, thanks to the resistance led by feminists in Croatia.

4. Mediterranean Ecofeminist Meeting

We have wanted to organize a meeting on "women and the environment in the Mediterranean" for several years, with the aim of helping feminists committed to defending the environment to network with each other. This had not been possible, mainly because of COVID, but we finally succeeded in October. Over two days, we brought together in Paris 16 participants (and three observers) from Algeria, Bosnia and Herzegovina, Croatia, Cyprus, Egypt, France, Greece, Lebanon, Morocco, Spain, Tunisia, Turkey, and Syria, as well as seven MedWF team members and a Prospera representative from Portugal. Three participants were unable to join the meeting, a Libyan and a Syrian due to visa issues, and a Palestinian due to the ongoing war.

This first meeting was an opportunity for each of the participants to present their local situations and the priorities they identified in relation to the environment from a feminist point of view, and for the group to begin a collective reflection at the Mediterranean level. The outcome of the meeting, which everyone agreed was highly productive and inspiring, was the creation of a Mediterranean ecofeminist network.

C. The FTCIs, feminist training in collective intelligence

The idea for a Feminist Training in Collective Intelligence (FTCI) emerged from personal experiences in the feminist movement and a widely shared observation, namely that associations, set up by extremely

courageous, dynamic women with a wealth of skills, do not operate to the best of their abilities either internally or in interaction with other associations, and it is possible to identify the key points where energy is wasted both at a psychological and organizational level.

- <u>At the individual psychological level</u>: poor self-knowledge, poor self-esteem, lack of self-confidence, lack of empathy for one's body and its needs.
- <u>At organizational level</u>: lack of listening skills in debates, difficulty for leaders to let go of control, difficulty in positioning oneself in front of an authority figure, inability to manage conflicts in a nonviolent way, lack of transmission of past experiences, lack of project-building methodologies, poor communication skills.
- <u>At the broader level of networks of organizations</u>: the same types of weaknesses as for organizations, with in addition a lack of openness toward others, a sense of being fundamentally threatened by other organizations, difficulty in assuming own political power.

This training thus aims to strengthen activists, organizations, and thereby the women's movement, by providing a space for committed women. This space is designed as a space of freedom where they can take time for themselves (as much as individuals as groups), get to know themselves and meet others, learn and discuss, strengthen themselves personally and reinforce each other, and form ties that will help them further their cause.

This year, in addition to a second face-to-face FTCI session in Morocco, our trainers helped design and participated throughout the year in the Feminist School set up in Algiers by one of the participants in our 2018 Training of Trainers.

Finally, in addition to the training modules on self-esteem run by our partner, Citoyenneté Possible, as part of our project with associations in lower-income neighborhoods, we have provided specific training to several associations in France and Algeria focusing on a collective intelligence tool, in particular the checkin and the relational charter.

1. Feminist Training in Collective Intelligence in Morocco

We were able to organize a new hybrid FTCI session in Morocco, combining elements from the three modules, to work on self-esteem, one's relationship with others and with one's group, and collective intelligence between various groups. The event was held in Aït Ourir between May 13 and 16, 2023.

As the session was intended to be intergenerational, it brought together 16 women, aged 18 to 50, from seven towns and 12 associations, and was held in Aït Ourir near Marrakech, the most accessible major city for most of the participants. Discussions were held in French and Arabic. The group was provided with full room and board for four days, including evenings. All of the participants were able to talk personally and professionally about their roles in the associations they represented, as employees or volunteers. The group was mixed both socially and geographically (young and older women, rural, urban, sometimes Berberspeaking, farmers and weavers, graduates and/or unemployed, volunteers or salaried employees, etc.).

This four-day training program was able to achieve its objective of identifying and naming the societal constructs and mechanisms of oppression against women. It is through experiences like this that it is possible to raise people's awareness. It is only after this has been achieved - starting from their own experiences, their own paths, their own conditioning - that people are able to name and conceptualize the struggles undertaken by feminist associations.

2. Follow-up of trainings

The FTCI programs aim to strengthen the women's movement by convincing the young women participating in them that they are strong and are part of a greater whole, locally and regionally. Since starting the FTCIs in 2013, we have systematically implemented a post-training follow-up which involves:

- **Information**: on a regular basis, we send all participants information which we think may interest them, including material on women's rights or calls for projects issued by international donors, invitations to participate in regional or international meetings or in human rights training programs issued by institutions and youth and women's organizations.
- Contacts. whether at their request or at the request of donors, journalists or other organizations, the MedWF makes it as easy as possible for the young women it has trained to reach out to the world. We helped the young women to participate in events/actions organized by associations several times over the year.
- **Referrals**: upon their request, the MedWF regularly recommends young women in search of employment to institutions or associations.
- Accompaniment: we see our back-up support as another form of training. This involves supporting
 a young woman individually as she reflects on issues, writes a thesis or develop a project, as well as
 inviting young women to attend local meetings with us so that they can learn about group dynamics
 in the safety of our company. Lastly, we help them consider the type of organization they would like
 to set up, as we have done in Algeria, France, and Morocco.
- **Refreshers on the tools learned**: we can do this informally during a conversation over the telephone, or in a much more formal way, as we did this year with a workshop organized in Algiers with young women trained by the Feminist School which reviewed methods for organizing collective action.

II. Communications and Fundraising

A. Communicate what we do as effectively as possible

Producing videos and articles, organizing events and conferences, maintaining our social network presence, and participating in meetings all require considerable efforts from our paid staff and Board of Directors. However, these efforts are crucial to convincingly explain why it is critical to support the fight for women's rights and women's networks in the Mediterranean region.

The challenge is to pay close attention to our communications while bearing in mind that it is a means and not an end, and taking care not to get bogged down in it. This means constantly weighing the investment required in terms of time and money against the results in terms of building our support network and fundraising.

1. <u>Website, biannual letter</u>

The number of pages visited on our website has continued to increase (by 29% compared to 2022). We hope to continue in this direction in 2024 and offer our visitors increasingly high-quality, easy-to-access content. The associations pages visited are more diverse than in previous years, which is in line with our communications strategy on our social networks and in our half-yearly newsletter.

The biannual newsletter

The biannual letter is published in French and English, both online and as hard copies. In 2023, the MedWF published two newsletters, two calls for donations (following the earthquake in Morocco and the emergency in Palestine) and a fundraising letter (sent to over 2,700 individuals and associations in French and over 600 in English). With an open rate of 36%, the biannual newsletter seems to be attracting readers. All our newsletters can be downloaded from our website, on the "Our resources" page. The paper version, with a print run of a few hundred copies, is distributed at events and meetings, and helps to establish a link with future beneficiaries and donors.

2. <u>Social networks</u>

Facebook

On our Facebook page, we share our activities, showcase the work of the associations we support, and keep our subscribers up to date on women's rights in the Mediterranean. Women represent 81% of our subscribers. Our Facebook page is read mainly in France (41%) and in the French-speaking countries of the Maghreb (Tunisia (11%), Algeria (8%), Morocco (5%)), but also in Italy, Egypt, Spain, Lebanon and even beyond the Mediterranean, in the United States and Belgium. This diversity means that we must vary our content to adapt it as much as possible to non-French-speaking audiences, and this poses a real challenge in terms of translation.

Less active on X (former Twitter), our number of followers increased by only 2%, totaling 912 at the end of 2023.

On the other hand, our Instagram account, launched in 2020 to reach a more image and video-oriented audience, is growing steadily and we now have 1,150 subscribers. This represents an increase of 24% compared with 2022. The objective is to showcase our work and the wide range of associations that we

support through a variety of posts (international days, presentations of associations, participations in conferences, organization of events, etc.).

We continue to maintain our presence on the LinkedIn professional network, where we have 1,963 subscribers, an increase of 44% compared with 2022. This is where we post our various activities, and in particular our job offers when we have some. We are also regularly mentioned by partners, which helps increase our visibility.

3. <u>Constitution of video archives</u>

In our view, this systematic documentation serves three purposes:

- The first is the most obvious: to demonstrate through short, three to six-minute films what we do, with whom we work, what people do with the support they receive from us, and what they think of our work. This provides us a brief assessment although we have no illusions about the bias introduced in an interview conducted by a donor and above all brings to life what we try to communicate as it is difficult to understand the profundity of actions and human feelings through a simple description. Since we started presenting short videos, our target audience now has a better understanding of our work and feels much more involved.
- The second purpose is to enable us to improve and better reflect on our own work. By visualizing our activities, and listening again to the interviews, we can better assess our methods, propose new ideas for strategies to implement, and, as we wish to make models of our trainings, this material will help us turn action into theory.
- Lastly, the third purpose of this documentation is to constitute archives for researchers and particularly the women's movement in the region (for example, strategy meetings are filmed in their entirety and copies are given to the women's associations involved).

In 2023, a series of video reports, interviews (17) and photos were produced during the following events/field visits:

- Strategic reflection meeting and mission to Split and Brač Island (Croatia), February;
- Strategic reflection meeting and mission to Beirut (Lebanon), May;
- Feminist training in collective intelligence in Ait Ourir (Morocco), May;
- Field visit to Algiers (Algeria), June;

.

- Mediterranean ecofeminist meeting in Paris (France), September.

4. <u>Organization of events</u>

Meetings with the Friends of the Fund

We regularly organize meetings in Paris and Montpellier to which we invite those we call "Friends of the Fund" (supporters, volunteers, donors, associations, young women in training, and so on). We present our work, training courses and strategic review meetings, and provide information on fundraising developments. These meetings also provide an opportunity to exchange opinions and ideas that fuel our thinking. These meetings are essential. On the one hand, they strengthen our ties with the growing number of people who support us, and on the other, they enable these people to become more involved in our activities.

In Montpellier, where the Friends of the Fund have formed a collective, we met at the Dôme on October 4. This meeting gave us the opportunity to explain what had happened to our partner associations which had suffered numerous natural disasters: floods in Libya and earthquakes in Morocco and Turkey. We explained to our friends how the associations have coped with these crises, what their needs were, how the MedWF has helped them and, also, what role we can play in rebuilding. We also explained the procedures we follow when a sudden crisis arises because, over time, we have developed and refined emergency procedures that have helped to bind the team even closer together.

<u>In Paris</u>, we organized a "Friends of the Fund" reception on October 11, bringing together around thirty people, massociations, donors, sponsors and other MedWF companions. It was an opportunity to show them our new offices, and present our team and our activities for the year.

• Organizing small events

.

On March 12, we also organized an event with the association Identités et Partage at the Espace Jacques d'Aragon in Montpellier, attended by over 60 people. The "*Des nouvelles de chez elles*" (News from back home) evening gave us the opportunity to take stock of women's rights in each of the countries around the Mediterranean, by reading letters written by women activists. We sang the songs that they sing at events, and listened to poems about them. The event closed with a performance of the play "*Comment je suis arrivé lå*" (How did I get here?), by Zohra Aït-Abbas.

In November, as part of our meeting with Mediterranean ecofeminists, we organized a cocktail party with the activists present, as well as several of our partners – donors and associations – to introduce them and have them meet each other.

Meetings between donors and associations

For the second year running, we organized online meetings between donors and associations, with the aim to forge links between activists on both sides of the Mediterranean. By inviting our partner associations to come and present themselves and exchange ideas, these events enable us to strengthen our ties and make them better known to our donors. These meetings are designed to be participative and, after a description of the context in which the associations operate and their many battles, the public is invited to ask questions.

The first meeting took place on April 19, with the idea of introducing our donors to the network of feminist journalists in the Mediterranean, MedFemiNiswiya. Journalists Olfa Belhassine and Ghania Khelifi presented MedFemiNiswiya, the first feminist network of journalists working in media and news production in the Mediterranean region. This trilingual network (French, English and Arabic) was born in 2018, during a strategic reflection meeting organized by the MedWF. It brings together some thirty journalists from various Mediterranean countries.

The second meeting took place on October 5, bringing together members of three MedWF partner associations. We invited Adjera Lakheal (feminist anti-racist activist), Mimouna Hadjam (Africa 93) and Paloma Feltre (Voix de Femmes), to talk about anti-racism and feminism. During the meeting, we discussed the convergence of feminist and anti-racist struggles, using the practical experiences of our partners as a starting point.

5. <u>Public appearances</u>

To make our work known and advocate for the rights of women and the financial support needed for their defense, members of our Board of Directors and our salaried team intervene whenever the occasion arises in public meetings, radio and TV shows, and online and printed media outlets.

Several MedWF members took part in webinars, virtual roundtables and face-to-face meetings:

- On January 24, Caroline Brac de la Perrière took part in the round table organized at the European Parliament by MEP Maria Nochtli and the European feminist funds on the theme "Mobilizing funding for feminist movements via feminist funds";
- On March 2, Noémie Friedli spoke to local Montpellier radio station Radio Clapas about the history of the Mediterranean Women's Fund, how women's funds support women's associations and who our supporters are;
- In a podcast produced in December 2023 by Charlène Petit, founder of the Philanthropio website, Fawzia Baba-Aissa was interviewed at length about the activities of the Mediterranean Women's Fund, the aims of feminist funds and why a number of funds and foundations and philanthropic organizations have joined forces in a coalition to advance feminist philanthropy. *To listen to the podcast: https://bit.ly/3Stpasc*

B. Fundraising

1. Fundraising in France

For several years now, we have been working to ensure that more than a third of our funds are collected in France. The amount has stabilized at around 45% and has diversified: individual donations, private foundations, corporate foundations, local authorities, the French Embassy, and the French Development Agency.

Local authorities and other French government bodies

As we are headquartered in France and subject to French law, we continue to pursue our efforts to establish partnerships with different institutions.

The "Feminists in Action" project, financed by the French Development Agency (AFD) through its Support Fund for Feminist Organizations (Fonds de soutien aux organisations féministes des Suds - FSOF), and implemented by the consortium comprising Care France, Equipop, Oxfam, and the women's funds IPBF, XOESE and MedWF, is continuing. Ten associations were supported in 2023, six of which had already received a grant in 2022 as part of this project, and several meetings and training courses were organized in the North Africa-Middle East region.

Private foundations

.

In France, few are interested in women's rights. We therefore try to collaborate with those who work in this field through the French foundations center.

This year, we were again able to count on the help of some of them, which already were convinced of the merits of our mission, for our general operations and for projects like the collective intelligence training program. They also demonstrated flexibility in a time of crisis like the one the world currently is going through, allowing us to use their grant for what we think is important when we cannot implement activities that were planned, and we are grateful to them.

Individual donors

Our goal is to weave a net of solidarity – a tangible movement – in which everyone feels they have a stake. Not everyone is able or willing to engage in the daily fight on the ground, but many are convinced that without the grassroots work done by feminist associations, the status of women would not have changed. Donations are a way of being part of the movement and demonstrating one's solidarity with the actions of associations.

Throughout the year we encourage people to make individual donations through, among other means, fundraising letters.

- This year, the series of disasters natural, as in Turkey, Morocco, and Libya, or caused by war, as in Gaza that affected the women's associations that we support in these countries prompted us to send out several appeals for donations to over 500 people by e-mail.
- We sent the fundraising letter in December, to 400 donors by post and to 400 people by e-mail.
- Since 2018, the MedWF has been referenced on Lilo, a search engine that turns the searches of the people who use it into drops. The drops are paid to a project listed on Lilo, in general social and environmental projects, according to the wishes of the internet user. The MedWF project listed is named, "Training young women leaders". Once a certain number has been reached, the drops are converted into money: this year, our friends' searches and donations of the drops generated raised several hundred euros. Having observed that our supporters' motivation to use this platform appeared to be waning, toward the end of the year we issued a new appeal to use Lilo and donate the accumulated drops to the MedWF. 2. <u>Fundraising outside France</u>

Private foundations and feminist funds

The support given by these foundations and funds is crucial for the MedWF. The multiannual support of the Sigrid Rausing Trust and the Oak Foundation, as well as the regular support from the Global Fund for Women, which allow us to use their funding to cover our operating costs, has radically changed our manner of envisioning the future and has enabled us to be more ambitious. We could continue to expand our team and confidently conduct our activities in 2023, thanks to several multiannual unrestricted grants.

This year, some of our most recent donors have renewed their support for specific projects. Examples are the Foundation for a Just Society for our "Knocking on EU's door" work with European women's funds, the Open Society Initiative for Europe for our major project on racist and gender-based discrimination in lower-income neighborhoods, and Calleva Trustees for a multi-year grant to certain associations. Finally, Fenomenal Funds has awarded us a new grant for our operating costs, as well as for a collaborative project on feminist leadership managed in partnership with the Calala Fund.

• Public funds

This year, in collaboration with the Ecumenical Women's Initiative, a Croatian women's fund, and the Spanish women's fund Calala, we obtained a grant from the European Union to combat violence against women. This project, entitled "SEE CHANGE", which will begin in 2024, will enable us to provide grants, organize meetings and make field visits to associations working on violence in Bosnia and Herzegovina, Croatia, Cyprus, Greece, France, Italy, and Montenegro.

III. Strengthening the Mediterranean Women's Fund

A. Strengthening alliances

Since it was created, the MedWF has worked with other donors that have the same or similar mandates as ours to ensure the greatest amount of support for women's associations in the region.

1. Collaboration with Prospera, the International Network of Women's Funds

The MedWF is a member of Prospera, an international network of women's funds, which includes 47 funds from around the world, all with a mission similar to ours. As it has every year, the MedWF developed several collaborative projects with this network and its members.

Collaboration by exchanging experience and sharing tools and know-how

Numerous meetings are organized over the year by the network or members of the network. They are occasions to learn, for example, new assessment methods, think about new fundraising strategies, and analyze the situation of women in different regions.

The African chapter met in Rwanda on July 13 and 14. The eight members of the chapter, including the MedWF, discussed how they could better collaborate in their support for women's and feminist movements in Africa and the Middle East. This chapter was created with the aim of forging links of solidarity, exchanges of experience and partnerships that are essential in building a world in which the transformation of power relations will make it possible to establish fairer societies.

The European chapter held its annual meeting in Armenia from October 16 to 19. We updated each other on our funds, developed strategies for our joint advocacy activities and discussed the implementation of Prospera's strategic plan. We also decided to set up a skills-sharing tool so that we could continue learning from each other.

Financial collaboration

As often as possible, the MedWF establishes agreements with other women's funds to support women's associations more efficiently in countries where they are working.

As a result, we have been able to continue, and increase financially, our collaboration with *Calala-Fondo de Mujeres*, relying on their knowledge of local conditions in Spain to ensure that our funding is allocated in the most appropriate way possible.

This year, we also continued a similar collaboration with the Croatian Ecumenical Women's Initiative fund, to effectively support the managerial transition of a women's organization based in Bosnia and Herzegovina. In addition, our close and trusting relationships with Global Fund for Women and African Women's Development Fund have led them to ask us to continue acting as intermediary in North Africa.

Collaboration around projects

We are actively collaborating with European funds on four projects:

The feminist leadership and management project with the Calala feminist fund. Fenomenal Funds, a group of donors dedicated to supporting Prospera women's funds, has launched a collaborative call for projects, with themes chosen by the funds themselves. In this context, we have designed and begun to implement a project with the Spanish fund Calala focusing on feminist leadership and management. This collaboration is particularly interesting because our two funds are at the same

stage of development and related reflection, and occupy a similar position within the network. We met near Montpellier in April, eight of us – four members occupying various positions in each of the funds – to present in detail our herstory, our organization, our operating methods, the problems we encounter, etc., and to discuss our future plans. It was a rich and very interesting experience, because we never usually have time to go into this level of detail about how we work.

- The "Knocking on the EU's Doors" project, coordinated by the Mediterranean Women's Fund and the Ecumenical Women's Initiative. After publishing a document at the end of 2022 entitled "Achieving gender equality through the women's funds model" highlighting the role and funding principles of feminist funds, to which thirteen women's funds from Prospera's European chapter contributed, we jointly organized an event at the European Parliament in January 2023 (see advocacy chapter).
- The "On the Right Track" project, the first collaboration between Prospera's European and Latin American chapters to combat the rise of fundamentalism and the far right, continued again this year. A meeting was held from May 31 to June 2, bringing together women's funds and our grantee-partners. This meeting enabled us to take stock of anti-rights movements, their strategies and their impact in each of the countries represented. We then shared our own counter-attacks/defense methods, which was very inspiring, and discussed the future of the project. The third day focused on the funding needed for counter-attacks, the role of women's funds, according to women's associations, and that of other donors.
- Finally, we continued our collaboration with women's funds around the world as part of a group working on the feminist crisis ecosystem, entitled "Feminist Alchemy", referring to the way in which women's funds set up funds and measures to respond to emergencies linked to economic, political, security, environmental and other crises. The objectives in 2023 were mainly to share our work as feminist associations and funds on emergency funding, and to discuss ways of responding to crises, lessons learned and prospects for the future. These points were discussed collectively at the annual meeting in Kenya, and regularly in several online meetings throughout the year. As part of the group's activities, surveys were carried out to contribute to research on trends and gaps in feminist work in crisis response, and a guide was produced. The aim of the research is to build a model of the feminist response to crises and, where possible, to highlight the differences between the traditional humanitarian response and this feminist response. The research has been concluded and the guide on feminist crisis response and the importance of flexible financing is in the final stages of translation and design.

The meeting in Kenya marked the end of the three-year Feminist Alchemy project, and was an opportunity to discuss the dynamics, achievements, needs and ways of continuing to collaborate. This would involve the preparation of a roadmap and a search for additional funding.

2. <u>Collaboration with other human rights and development foundations</u>

Through networks

.

The MedWF also is a member of numerous networks of donors involved in human rights and/or development (Edge, Ariadne, French Center of Funds and Foundations, etc.). The meetings organized by the networks are held fairly frequently and are all interesting: we meet people with experience in our field and have the opportunity to discuss ways we might work together.

We were able to attend several of them:

- Ariadne's "Great Reconnect" in March, in Berlin, where we took the opportunity to present the report on feminist funding principles undertaken with Prospera's European funds.
- From May 23 to 25, we took part in Philea's annual conference in Croatia, which brought together over 700 philanthropy and civil society professionals. We had some excellent discussions about the future of philanthropy in Europe, the challenges we face as funders, why we need to better fund

systemic change and how we need to ensure that no one is left behind.

- The "Women Deliver" international conference on gender equality was held in Kigali from July 17 to 20. It brought together thousands of women's organizations, feminists, government authorities and global agencies, with the aim of making it a space for advocacy to advance gender equality worldwide. Over and above the interesting discussions and debates that such a forum generates, we must highlight an alarming fact: the opening of the conference was entrusted to Katalin Novák, the then President of Hungary and an emblematic figure of the anti-rights movement. She is known for regularly obstructing any progress in favor of the rights of women and LGBTQIA+ people, both in her own country and in multilateral forums. This speaks volumes about the worrying spread and influence of the anti-gender movement, which even manages to get itself invited into feminist spaces to promote its ideology.
- On November 28 in Brussels, at a meeting organized by the Alliance for Gender Equality in Europe, on the theme of "Impactful Strategies to Achieve Economic Gender Equality in Europe".

Or individually, on a project

We continued our collaboration with the Calleva Foundation, helping to identify projects corresponding to its areas of interest in Lebanon and Morocco and then acting as an intermediary. Further affirming its confidence, the Foundation has even increased its financial support.

Likewise, as part of our partnership with the Kering Foundation to assist associations working to combat violence against women, we have continued to support French and Italian organizations.

And providing emergency support for associations

The Mediterranean region has faced several serious crises this year: earthquakes in Turkey, Syria and Morocco, floods in Greece and Libya, war in Palestine... Several of our donors have responded to our requests and granted us exceptional funding, enabling us to provide additional support to help our partners on the ground to cope with the challenges facing them. This emergency funding accounted for almost 30% of our grants.

3. Advocating for more funding for associations

This year, we strengthened our advocacy efforts, both at the national and international level.

In France

In 2023, the MedWF continued to engage in advocacy actions:

• With major institutions in France

One piece of good news for 2023 is that the Support Fund for Feminist Organizations (Fonds de soutien aux organisations féministes des Suds - FSOF), a funding mechanism launched in 2021, was extended in 2023 for a further three years, with an amount of €240 million. This fund is co-piloted by the Ministry for Europe and Foreign Affairs (MEAE) and the French Development Agency (AFD).

Once again this year, the MedWF has continued to advocate that funding should target the priorities decided by feminist groups and should be flexible, and that accountability mechanisms should be as light as possible. This work is carried out at different levels:

- alongside members of the FSOF-funded Feminists in Action Consortium;
- in the FSOF Steering Committee, as one of our members has been invited to join. Its mission is to
 provide expertise on the transformative aspects of the FSOF, its overall operations and its strategic
 directions;

- supporting the women's funds of Prospera's African chapter this year, with a view to establishing dialogue and working relationships, in particular with the Ministry for Europe and Foreign Affairs around the FSOF.

At the same time, as part of the renewal of France's international strategy for feminist diplomacy, the MedWF was asked this year by the MEAE to take part in a "feminist activists" working group. The aim was to contribute, together with other civil society organizations, to identifying specific priorities and objectives to ensure the full, equal, and meaningful participation of women and feminist activists in international decision-making processes, and to reflect on the different types of support to be given to them, particularly in situations of crisis, and the rise of anti-gender movements around the world.

Furthermore, as part of the Feminists in Action project supported by the AFD, consortium members organized an advocacy campaign, with a delegation of representatives from feminist associations supported by the project coming to Paris. This "advocacy mission" took place in Paris, from January 23 to 29. For this first initiative, the consortium has given priority to French-speaking feminist representatives from sub-Saharan and North African countries. The main aim of this advocacy mission was to encourage direct dialogue between French decision-makers and representatives of grassroots feminist organizations. The MedWF hosted the entire delegation at its Paris offices, and also invited private donors.

• With private donors

The MedWF continues to advocate towards funds and foundations in France, with the aim of increasing resources to support gender equality. That is why we initiated, alongside Fondation CHANEL, the Fondation de France and the Raja Foundation, the Coalition for Feminist Philanthropy (CPF). On June 20, in Annecy, the coalition was officially presented at the annual meeting of the French Center of Funds and Foundations at a round table entitled: "Promoting feminist philanthropy as a catalyst for a more egalitarian society". Among other points, it recalled that between 2016-2019, only 8% of global philanthropic funding for development, i.e., \in 3.17 billion, targeted gender, while during approximately the same period (2009 to 2018) no less than \notin 659 million was spent on anti-gender funding in Europe, including \notin 111.8 million in France.

Internationally

Women's funds play a key role in advocating towards major institutions and philanthropic bodies (foundations, companies, corporate sponsors, institutions, etc.) to give greater support to the women's movement worldwide.

We therefore continued our efforts with the European Union, further developing the "Knocking on EU's Door" project, which aims to convince the European Commission of the importance of funding women's funds and organizations, and to facilitate access to funding dedicated to gender equality. For several years, the European Union has been pursuing two major strategic directions regarding gender equality: in internal EU policy, the European Strategy on Gender Equality, and in external policy, the Gender Action Plan, the results of which have fallen short of expectations.

The MedWF and Ecumenical Women's Initiative, who are coordinating the project for the European women's funds, have worked intensively with their advocacy expert to establish communications and connections with key institutions, working groups and advisory committees, both at the European Commission and among members of the European Parliament.

This year's advocacy activity produced two tangible results:

- an openness to securing long-term policy, partnerships, and funding from EU institutions to maximize the visibility and impact of Prospera's Women's Funds Europe (WFE) network;

- the definition of a clear role for the involvement of European women's funds in the Gender Action Plan III (GAP III) - the EU's external strategy covering all countries outside the EU (neighboring countries, Africa, Asia and the Americas) and the European Gender Equality Strategy.

Alongside these key achievements, several important activities were carried out, including:

o Advocacy actions

- Successful preparation and launch of a major round table at the European Parliament by Women's Funds Europe (WFE) on mobilizing funds for feminist movements, which took place on January 24. WFE presented best practices and recommendations from the successful Erasmus+ project on its innovative grant-making model that is revolutionizing the sector. WFE highlighted how to amplify the voice of feminist movements by strengthening legislation, such as the European directive on gender-based violence. With over 60 participants, the event helped consolidate the impact and launch a call to action for long-term funding for women's funds in Europe and globally.

- Influencing the financial contributions of Gender Action Plan III over the duration of the program to 2027 -WFE has regularly engaged with the European Commission and EU delegations in the African region, Serbia and Armenia to reinforce the importance of involving civil society organizations at all levels in the consultation, implementation and reporting of GAP, and providing them with the resources they need to do so.

• Partnership development initiatives

Obtaining high-level support from the European Commission for a strategic contribution and political support for women's human rights in Europe: the European women's funds approached more than 30 officials from EU institutions, including eight special advisers (the most senior officials) to the European Commissioners for Equality, Values and Transparency and International Partnerships, as well as the chairs and coordinators of the Women's Rights and Gender Equality (FEMM) and Development Committees.

• Funding initiatives

Four women's funds, including the MedWF, obtained and mobilized more than €8 million, 70% of which was for grants to grassroots women's civil society organizations under the "Citizens, Equality, Rights and Values" (CERV) program.

B. Strengthening the organization

1. <u>Team building</u>

We use the term 'team' to include, in the broadest sense, the salaried staff and members of the Board of Directors (including the Executive Committee) of the MedWF because the staff receives considerable support from the members of the Board of Directors, who come from a wide range of complementary backgrounds and are highly committed and experienced. They devote a great deal of their time to the development of the MedWF, on tasks relating to operations (monitoring donations, website, database, fundraising), strategy and, above all, outreach. Thanks to them, the MedWF has begun to gain a receptive audience in public and political circles, particularly in France.

The **Board of Directors** is made up of Marta Giral, Christine Buttin, Fawzia Baba-Aissa, Axelle Maldidier, Alya Cherif Chamari, Fatem-Zahra Bennis, Laura Jovignot, Mathilde Mondon and Sarah Swaydan.

At the end of 2023, the **management team** consisted of nine paid staff, six of whom were paid part-time to a greater or lesser extent, and one part-time consultant for advocacy and development, for a total of 8.07 Full-Time Equivalent. The team's size is finally beginning to more or less match the amount of work we have to do and our goals, and it is becoming increasingly solid, well-organized and autonomous.

2. Drawing up the 2024-2028 Strategic Plan

Throughout the year, we held a series of in-house meetings, organized either in thematic sub-groups, or bringing together the entire management team and the Board of Directors, to map out future strategies up to 2028. This required the team to undertake a considerable amount of additional work, which also proved to be very useful in sharing with new members of the team our vision and the reasons for the direction we are taking. The Strategic Plan was finalized in December by the consultant, after a two-day retreat attended by 16 people who agreed on the vision and mission of the Mediterranean Women's Fund and outlined the main thrusts for the coming years, which will be transmission and transition.

3. <u>The Friends of the Fund</u>

As time goes by, the MedWF has gained growing support for its activities, gathering around us an increasing number of people who wish to contribute to our efforts.

We rely first and foremost on the availability and commitment of the members of the Board of Directors, who give a great deal of their time and expertise, especially when we are working on the future Strategic Plan. We are also supported by the ever-growing number of those we call the Friends of the Fund, who offer their know-how, time and energy, make their homes, cars and equipment available, forge links and thus enable the team to increase its action tenfold.

Among them are translators, artists, consultants, trainers, graphic designers, IT specialists and other support services providers who are not only highly skilled, but often do part -- or all -- of the work on a pro bono basis.

In particular, we can see the immense contribution made by their involvement in events such as training courses and meetings, but also, and very importantly, by their wide-ranging advice.


It was undoubtedly this support that enabled us to make a qualitative and quantitative leap forward in the development of the Mediterranean Women's Fund.


In 2023, the contributions made to the Mediterranean Women's Fund in the form of volunteer services and material aid were worth over €53,000.


